**I. PROCEDURAL HISTORY**

1. On 30 July 2021, the Respondent requested a four-week extension to file its Reply Memorial on Jurisdiction. Further to the Tribunal's 31 July 2021 directions, on 2 August 2021, the Claimants commented on the Respondent's extension request.
2. On 2 August 2021, the Tribunal granted the requested extension to submit the Respondent's Reply on Jurisdictional Objections on 1 September 2021, and the Tribunal granted the same additional term for the filing of the Claimants' Rejoinder on Jurisdictional Objections.
3. On 26 and 27 August 2021, the Parties agreed to the Tribunal's proposal that the Hearing on Jurisdictional Objections would be held virtually between 28 March and 1 April 2022.

**II. ORDER**

4. The Tribunal adopts the modified procedural calendar set out in Annex A to this Procedural Order, which incorporates the extensions previously granted and the agreed dates for the remote Hearing on Jurisdictional Objections.
